# Youth Services Section Executive Board Meeting June 11, 2019

The Executive Board met for the 7th meeting of the 2018-2019 Biennium at the Iredell County Library in Statesville at 12 noon. Attending were: Chair Meg Smith, Sec/Treasurer Helen Yamamoto, Vice Chair Lisa Donaldson, Director Julianne Dunn, State Library Youth Consultant Jasmine Rockwell, and NCCBA Liaison Janet West.

## **Agenda**

Meg called the meeting to order at 12:25 p.m. Meg moved to approve March meeting minutes, Lisa seconded. The minutes were approved.

## **Budget**

Helen emailed YSS balance out after the meeting. (Balance is \$13,811.59 as of first quarter 2019).

State Library Updates

They are interviewing Assistant State Librarian now and hope to have someone in place by July 1. They are still in the process of hiring the Head of the Government Heritage Library.

Upcoming workshops:

Katy Scherer – Movement and Play

Jennifer Luetkemeyer – Planning and Intentionality in the Summer Reading Program

Jewel Davis - Diversity in Programming

Summer reading workshops will occur in alternate years.

NC Autism Society is planning six workshops across the state.

The State Library is in phase 2 of a 3-phase, YALSA IMLS Grant-funded Train the Trainer series. During this phase Jasmine and a front-line librarian will get the training and then roll it out to the state. The theme is on connected learning and computational thinking in a low-tech environment. They will each present 30 hours of training throughout the state after taking the workshop.

The State Library's conference scholarship procedure is changing (except for ARSL and NCLA). There will be a generic application that allows applicants to specify the particular conference for which they want financial assistance.

In July there will be health literacy grants for public libraries proposing health programming, with a focus on multi-generational programming.

Forward Together Training was presented, and Jasmine attended. The training focused on poverty and attendees were required to bring a community partner to the training. Over 2.5 days, the attendees participated in a poverty simulation and heard speakers talk about the effects poverty has on NC residents.

There will be another training at the end of September. Up to 80 people can register. The State Library will offer poverty simulation kits on loan, and on the second day of the event, will explain how libraries can use them.

Flow Circus Kits can be checked out from the State Library. The State Library plans to do more training using these kits in the future.

The State Library is developing a pilot program for their Professional Collection.

CSLP is September 16-19 in Indianapolis. Jasmine is on the planning committee. Another YSS Board member will accompany her.

### **NCCBA**

Participation from public libraries has typically been low. NCCBA will start providing signs, ballots to encourage increased participation.

The new website is working, and they have seen an increase in nominees. More public librariaaes participated this year, as well, although the number of votes was lower.

The committee increased the number of nominees in the Junior category to 10, from 8. There are also 10 picture book nominees. Janet shared the 2020 list of nominees.

YSS agreed to donate \$250 to NCCBA again this year. **Janet** will send the name/address to Helen.
